Further, inconsideration of my participation in CareFest the undersigned also expressly declares and agrees:

In addition, owner will permit the use of the bathroom and plumbing facilities for the individuals performing the improvements.

5. The owner agrees to permit the committee to place a promotional sign on said property if desired;
6. That all claims, past, present, or future are disputed and this full and final Release thereof shall never be treated as evidence of liability, nor as an admission of liability or responsibility at any time or in any manner whatsoever;
7. That the undersigned will indemnify and hold harmless the said parties released hereby, against loss, including counsel fees, from any and every claim or demand of every kind and character, including claims for contribution, which may be asserted by the undersigned by reason or said occurrence, injuries or the effects or consequences thereof.
8. That the undersigned agrees and authorizes the committee to perform a background check, if necessary and to provide information required to perform said background check.
